Walkie Talkies Pros & Cons

Pros:

- Tried and proven
- Communicating audio of verbal information
- Not dependent on carrier network

Walkie Talkies Pros & Cons

Cons:

- Expensive
- Devices to be charged
- A little bulky
- No access when you go home
- Only talk
- No written transcript
- Distance is limited by the range

Cell Phones Pros & Cons

Pros:

- Text messages (One-to-one or group)
- Store information
- Always carried by the personnel use personal device

Cell Phones Pros & Cons

Cons:

- Employees may not want to use their own phones → You can provide them a company phone
- It is carrier dependent
- Not a solution for broadcasting audio messages



Two types of texting: Inbound Texting

- User text in
- Get information back
 - Plain text
 - Photo/video
- Sign up for list
- Opt out
- Ask a question
- Engage in a text chat



Two types of texting: Outbound Texting

- Push out texts
- Ask a question
- Text chat
- Provide some form of info



Why is texting gaining so much popularity?

- Cheap or free for users
- Matches behavior of an attention deficit generation especially millennials
- Very fast
- Powerful can get a link to a specific page, opt in to a list, get info back instantly
- 98% read instantly
- Opting out works, unlike email where email addresses are sold
- 24/7 reporting on every text sent or URL clicked

- Build lists
 - You upload an excel file
 - People can voluntarily opt in by texting in
- Mobile website: add any content you like
 - Easy drag-and-drop system
